

STATUTORY PROPOSAL FOR A PRESCRIBED ALTERATION TO STOKE NEWINGTON SCHOOL AND SIXTH FORM – Creation of Additional Resource Provision for SEND at Stoke Newington School and Sixth Form

The School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013

### 1 School and LA details

# 2 Description of alteration

The London Borough of Hackney proposes to establish Additional Resource Provision (ARP) at

• Stoke Newington School and Sixth Form (Social, Emotional and Mental Health (SEMH) ARP; 30 places in addition to the school's PAN of 255)

The ARP is expected to open by the end of 2025, at a separate site across the road from the school (formerly the Daniel House building) with building works carried out as required.

### 3 Implementation and any proposed stages for implementation

If the proposal is agreed the Council plans to undertake the detailed design and procure a contractor during 2024. Building works are planned to start in early 2025, with a view to delivering the facilities for the new ARP by the end of 2025 (subject to further surveys, detailed design, planning and procurement).

Pressure in the construction market and unknowns on the site may create some challenges in achieving this project within the existing budget and expected programme. If the planned timescales are not achievable, the opening of the new provision may need to be reviewed or postponed.

#### 4 Evidence of demand

Hackney, like other local authorities, has seen a significant rise in the demand for SEND places.

- The number of Hackney children and young people with an EHCP increased from 2,645 in 2021 to 3,062 in 2022 (an increase of 16%).
- The number of Hackney children and young people with an EHCP rose from 3,062 in 2022 to 3,243 in 2023, equivalent to a 6% increase.

• The percentage of resident 0-24 year olds in Hackney with an EHCP was the second highest among statistical neighbours (4%), and the 9th highest across England.

We have seen a significant increase in the number of pupils requiring SEND support for Social, Emotional and Mental Health (SEMH) Needs in the secondary sector. Hackney has a primary ARP for children with Social, Emotional and Mental Health Needs at Gainsborough Primary School but no such provision in a mainstream setting for secondary-aged pupils.

# 5 Objectives

# 5.1 Special Educational Needs and Disability (SEND) provision

The ARP at Stoke Newington School and Sixth Form will admit children with an Education, Health and Care Plan (EHCP) with a primary need of Social, Emotional and Mental Health (SEMH) Needs. The provision will enable the increasing number of children with identified SEND to benefit from attending a mainstream school, whilst also receiving specialist input relevant to their needs.

Children attending the ARP will benefit from an individualised specialist curriculum designed to meet the SEND needs of children. Staff in the provision will deliver a differentiated curriculum and use materials and teaching approaches which promote the best possible academic, social and emotional outcomes for children.

Admission to the ARP will be determined by the London Borough of Hackney's Education, Health and Care Panel.

### 5.2 Hackney's SEND Strategy

The London Borough of Hackney has a statutory duty to provide sufficient school places for Hackney resident children. It also has a statutory duty to keep under review its educational provision, training provision and social care provision made in its area for children and young people who have special educational needs or a disability. In recommending this proposal to set up an ARP at Stoke Newington School and Sixth Form, we are delivering Priority 1 - 'Outstanding Provision and services' of our SEND Strategy 2022-2025. ### School changes

Hackney Education will support viable expansions of popular and successful schools in line with Department for Education (DfE) policy wherever possible.

# Quality and diversity

Hackney Education will seek to ensure that sufficient attractive high-quality state-funded school provision is available within the borough to meet the needs of all children. The new ARP will form part of Hackney's existing offer of well established ARPs for autism, speech, communication and language, and social, emotional and mental health needs, in addition to two special schools. This proposal will therefore

broaden the local offer for parents by providing additional in-borough, specialist provision and forms part of the wider implementation plan for additional SEND places.

# School budgets/finances

Hackney Education will consult with schools prior to the implementation of any changes to the funding of maintained schools. The funding will be allocated in line with the Operational Guidance, School Funding Regulations and endorsed by Schools Forum.

# Education property

Hackney Education will seek to ensure that school premises are well maintained, fit for purpose and meet all relevant national standards for space and health and safety.

## 6 Project costs and funding

The projected cost for the 30-place ARP at Stoke Newington School and Sixth Form is £2,000,000. The cost of these additional places will be funded from the High Needs Provision Capital Allocations Grant. These costs are subject to change through the detailed design and construction stages.

The ARP will not remove funding from the mainstream schools, as it will be fully and independently resourced. The creation of the new provision is expected, over time, to reduce reliance on costly out-of-borough and independent provision and transport costs, as the number of places available within Hackney is increased and Hackney children are educated in-borough.

#### 7 Consultation

To inform this proposal, the London Borough of Hackney ran an initial public consultation from 11 January to 7 February 2024. Of the 29 respondents who filled in a response form, the majority agree with the proposal to create an Additional Resource Provision for Social, Emotional and Mental Health (SEMH) (strongly agree and agree combined: 93%, 27 respondents). One respondent strongly disagreed and one respondent neither agreed nor disagreed. In addition, one respondent's response was summarised by an officer after a telephone conversation. This respondent strongly disagreed with the proposal.

All responses, including those expressing doubts and opposition to the proposal were considered by the London Borough of Hackney at a meeting on 28 March 2024. # 8 Decision-making

The decision-maker for this proposed expansion is the Director of Education at the London Borough of Hackney, in the event that no objections are received. If objections are received, a decision on the proposal will be made by the London

Borough of Hackney's Group Director for Children and Education. A decision must be made within a period of two months of the end of this representation period.
