## Job description

---

Purpose of the post:

- To work under the instruction/guidance of teaching/senior staff to undertake work/care/support programs. To enable access to learning for pupils and to assist the teacher in the management of pupils and the classroom. Work may be carried out in or out of the classroom or outdoor teaching areas where appropriate **and in the lunch hall and playground**

---

Main duties and responsibilities:

### Support for Pupils:

- Supervise and provide particular support for pupils, including those with special needs, ensuring their safety and access to learning activities.
  - Assist with the development and implementation of Individual Education/Behaviour Plans and Personal Care programmes.
  - Establish constructive relationships with pupils and interact with them according to individual needs.
  - Promote the inclusion and acceptance of all pupils.
  - Encourage pupils to interact with others and engage in activities led by the teacher.
  - Set challenging and demanding expectations and promote self-esteem and independence.
  - Provide feedback to pupils in relation to progress and achievement under the guidance of the teacher.
  - Deliver pastoral and learning support.
  - Deal with minor incidents and the health and hygiene of the children and where necessary, escort them home.
  - Read with individual children and groups and complete reading records as directed by the class teacher.

- Under the direction of teacher, work with small groups of children and take responsibility for their learning

### **Support for the Teacher:**

- Create and maintain a purposeful, orderly and supportive environment, in accordance with lesson plans and assist with the display of pupils' work.
- Use strategies, in liaison with the teacher, to support pupils to achieve learning goals.
- Assist with the planning of learning activities.
- Monitor pupils' responses to learning activities and accurately record achievement/progress as directed.
- Provide detailed and regular feedback to teachers on pupils' achievement, progress, problems etc.
- Promote good pupil behaviour, dealing promptly with conflict and incidents in line with established policy and encourage pupils to take responsibility for their own behaviour.
- Establish and maintain constructive relationships with parents/carers by supporting their role in pupils' learning, providing constructive feedback on pupils' progress and achievements and facilitating their support for their child's attendance;
- Support home to school/community links.
- Administer routine tests and invigilate exams and undertake routine marking of pupils' work.
- Provide clerical/admin, support e.g. photocopying, typing, filing, money, administer coursework etc.
- Work within an agreed system of supervision with small groups of children and take responsibility for their learning.
- Work in partnership with the teacher to support the school induction programme. This may include contributing to parents evening as appropriate.

### **Support for the Curriculum:**

- Undertake structured and agreed learning activities/teaching programmes, adjusting activities according to pupil responses.
- Undertake programmes linked to local and national learning strategies e.g. **English**, **maths**, early years and record achievement and progress and feed back to the teacher.
- Support the use of **computing** in learning activities and develop pupils' competence and independence in its use.
- Prepare, maintain and use equipment/resources as required to meet the lesson plans/relevant learning activity and assist pupils in their use.

### **Support for the School:**

- Be aware of and comply with policies and procedures relating to child protection, health, safety, security, confidentiality and data protection, reporting all concerns to an appropriate person.
  - Be aware of and support differences and ensure all pupils have equal access to

opportunities to learn and develop.

- Contribute to the overall ethos/work/aims of the school.
- Appreciate and support the role of other professionals.
- Attend and participate in relevant meetings as required.
- Participate in training and other learning activities and performance development as required.
- Assist with the supervision of pupils out of lesson times, including before and after school and at lunchtime.
- Supervise children at meal times and during lunchtimes (if appropriate to hours worked)
- Support children in breakfast club, in after school club **or extended day provision** (if appropriate to hours worked)
- Accompany teaching staff and pupils on visits, trips and out of school activities as required and take responsibility for a group under the supervision of the teacher.
- Assist in the general care of the school environment by undertaking tidying of general areas.
- Promote equal opportunities at all times.
- Establish constructive relationships and communicate with other agencies/professionals, in liaison with the teacher, to support achievement and progress of pupils.
- Recognise own strengths and areas of specialist expertise and use these to lead, advise and support others.
